



NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:



And further the Trustees are authorized to take and receive and accept funds from any other person or persons as per applicable government procedure (Trust, institution any among for being added to the corpus or by way of contributions, donations, settlement for carrying out and/or performing any one or more of the objects for which this Trust has been created established and any spend any part of the income arising there from on such terms and conditions as may be mutually agreed upon between the Trustees from time to time.)

I. Name: The name of the Trust shall be AMAR CHAND KUNDU EDUCATIONAL TRUST hereinafter referred to as the "TRUST"

II. REGISTERED OFFICE: The Registered office of the trust shall be situated at 47A / 1/2 Rajkrishna Ghoshal Road, 3rd Floor, Kasba, near Revival Nursing Jalinda Ser

III) THE LOCAL ADDRESS OF THE TRUST: shall be situated at Vill.& P.O. - Kandra, P.S. - Ketugram, Dist - Burdwan, PIN - 713129, West Bengal.

IV. FUNDS OF THE TURST: The corpus and the assets together with all further donations and contributions, and accretions in any shape or form will be made to and / or be received by the Trust form time to time and the rents profits and income thereof and the stocks, funds and properties representing the same shall be held by the trustees upon trust for the objects and purposes and subjects to be powers and Provision hereinafter set out.


- V. OBJECTS: The objects for which the trust is established are as follows:


- (v) To open, establish or finance and/or assist and contribute to the maintenance of hospitals and/or institutions for promotion and/or research and education in medical services including surgery.



- (xv)To sink tube wells and to provide water either through tube wells or by digging well for supply of drinking water and to establish piayous for making available water at palces where it is scares and or needed. To sink tube wells, arrange for wells, Bewaris, water tanks and to make available water by all possible means. for the benefit of general public
- (xvi) To construct Road High ways, bridges, parks, gardens and/or maintenance and / or grant aid for construction and/or maintenance and/or repairs of the same for the use and benefit of the general public.
- (xvii) To construct dwelling units for economically weaker section for their use and occupation without fixing any price for the same.
- (xviii) To finance assist aid or provide for promotion of sports in one or several fields for the benefit of general public.
- (xix) To induct the propagation and improvement of value and ethics in society inter alia through arrangement of lectures, discourse meetings etc. to be addressed by eminent and notable persons in different fields.
- (xx) To provide for any efforts and opportunities and facilities in the field of education , scholarship, free studentship and other financial assistance to the students.

(xxi) To grant aid and/or help in the marriages of poor and destitute girls.


- (xxii) To render assistance and/or grant aid to the promotion, growth and development of Indian Art and Culture.

- (xxix) To open management, I.T. Technical, dental, medical, nursing colleges, Pharmacy College, Teahcer's Training Colleges, Industrial Training Institutes and research institutions should be opened for the benefits of the common public.
- (xxx) No trustee shall receive any amount of money as profit keeping in mind that the trust is a body of non profit. There shall be no discrimination on the grounds of race, casts, creed, community or sex in carrying out the objects of the Trust.

VI. BOARD OF TRUSTEES:

All the properties to the Trust shall remain vested in the Board of Trustees (hereinafter referred to as the Board) which shall consist of not less than four Trustees and not more than Ten Trustees.


The present Board of Trustees consists of the following persons:

The persons for the time being constituting the Board shall have the power to increase the strength of the Board by appointing thereto one or more persons, whether on the same occasion or on different occasions, as trustee or trustees, so, however, that the total number of persons constituing the Board shall at no time exceed Ten and shall not be less than four. Sri Amar Chand Kundu shall be the first Chairman of the Trustee Board. He will assume the said post for life. The Trustee Board shall be entitled to open and where necessary, close accounts in the name of the Trust in any Schedule Bank, Post Office or in any other financially sound institutions and the same will be operated by mutual decision of board of trustees.

Subjects to the restrictive provisions of the Indian Income Tax Act, as amended form time to time, the Board may make and vary the investments from time to time at their sole discretion and to invest the trust estate of such portion thereof as it may think fit and proper in any manner fit any of the proposes aforesaid to convey the properties and to sing and execute transfer deeds.

The Trustees themselves or through their Constituted Attorney may institute, conduct, defend, compund, setttle, withdraw compromise adjust refer to arbitration or Turstees of against its officers or employees concerning the affairs of the Trust to sign and verify Vakalatnama, Plaint, Written Statement, execution petitions, affidavits and other papers and also to appoint Advocates and /or agent.



The Board may borrow form time to time such sum of money at such reasonable rate of interest or without any interest for such period and on such terms with or without security movable or immovable and to secure payment there of with interest or without interest, by mortgage or by bond, promissory, bills, hundies and other negotiable securities or by issue of debentures, from any bank of financial institution as it may decide for the same purpose for which it is established.

The Board may appoint and constitute management body or bodies for institutions started, run, managed or aided by the Trust and to make rules and regulations for the conduct of such managing bodies and running of such institutions from time to time and may vary such rules and regulations it necessary for the sake of its objectives.


The Board may accept for the purpose of the Trust any money or securities or any other movable or immovable properties from the Settlor or from any person, firm, company, other trust, institutions, organizations, Association of person, local bodies Government etc, by way of gift or grant or donations to the corpus of the fund of the Foundation or under an will for the objects started in Clause IV. Para 4 above or earned or earmarked by any donor for carrying out any one or more of the object as may be desired by the Donor or as may be specified by the Donor for the benefit of the Trust.

The Board may make or alter bye laws for the conduct of the meetings of the trustees and for the purpose of running and managing the affairs of the Trust.

The authorities and powers of the trustees hereby conferred and all acts, matters and deeds required to be done and performed by the trustees may be done and performed by the remaining trustees or the trustees for the time being during the period of any vacancies and all such acts matters and deeds done by the remaining trustee or trustees for the time being shall be valid and binding on the Foundations.

The Board shall from and out of the income realized from the properties, assests and funds of the Trust, and from such other endowments from the Government the Govenrment grants and from any other socurces which is may get, expend and/or spend such sum or sums of money as they may deem proper towards maintenance of the properties of the Trust, pay all rates and taxes pay such sums towards the repayment

of the Trust and in particular pay the salaries and allowances of all staff and servants purchases books, equipments and furniture etc? award relating to the Institutions if any for the benefit of the Trust.

The Board may also elect a Vice Chairman from amongst its members for such period as may be specified by it for the period for which the person so elected continues to be a trustee, whichever period expires earlier.

Not withstanding any thing contained in other provisions of this Deed Amar Chand Kundu will continue as the chairman of the Board during his pleasure and shall not be liable to be remove in the event of vacancy in the office of the Chairman, the Board shall elect a Chairman from amongst themselves.

If any of the trustees shall die, or desire to retire, or refuse or become incapacitated to act as a trustee or take to the benefit of the Law of Insolvency, then and in every such case, there shall be a Vacancy in the Board.

A trustee may be removed from office for misconduct or for obstruction to the functioning of the Trust by a resolution adopted by two-thirds majority of the members of the Board present and voting at a meeting specially called for the purpose. The Trustee affected shall be given reasonable opportunity to show cause against the proposed action.


Vacancies in the Board shall be filled in by the remaining trustees. The quorum of the Trustee Board shall be of one third members of the trustee board Vacancies in the Trustee Board shall not invalidate any of the proceeding of the Board.

The Board may meet as often as necessary and in any event not less than twice in a calendar year.

Declaration at the meeting of the Board shall be taken by a vote of the majority of the trustees present. In the case of equality of votes, the chairman of the Board shall have a second or casting vote.

The Trustees may form time to time make regulation as to their meetings and the conduct of their business and otherwise as to the management of the Trust affairs. A resolution in writing singed by all the trustees present in India for the passed at meeting of the trustees duly called and convened.

DUTIES AND POWERS OF THE TRUSTEES: VII



Management of the trust not hereinbefore specifically mentioned it being understood that the above enumeration gives on priority to any particular item of expense none is the same exhaustive.

The trustees shall in all respects, act according to the resolution of the board and conform in every respect to the Rules and Regulations made or directions given by the Board from time to time relating to the affairs to the trust including the exercise of the voting power in relation to the securities belonging to the trust.

The Board shall have management of the affairs of the Trust and the overall supervision and superintendence of the Trust and all institutions run by the trust and all matters incidental thereto.

VIII. REGULATION, FUNCTION AND POWERS OF THE BOARD.

The board may nominate, constitute and / or appoint attorney or agent and subject to such conditions and limitation as it may deem fit, delegate to such attorney or agent all or any of the powers vested in it.

The Board may, subject to such conditions and limitations as it may deem fit delegate such powers to a single trustee as may be necessary for the efficient functioning of the Trust or any of the institutions run by it.

The Board may, subject to such conditions and limitations as it may deed fit and necessary, delegate any of its functions to that secretary/s or any other officer or employee.


IX. ACCOUNTS AND AUDIT:

A Chartered Accountant or firm of Chartered Accountant who will be appointed by the Board shall audit the accounts of the Trust every year.

The audited accounts of the trust shall be adopted at a meeting of the Board called for the purpose.

X. INDEMNITY:

The trustees shall be chargeable only for such moneys, stocks, funds, deposits and securities as they shall actually receive, notwithstanding their signing any receipt for the sake of conformity and one of them shall be answerable for any acts or deeds of the co-trustees or any banker/ s, broker/s and other person/s in whose hands the Trust property has been placed nor for allowing a co-trustee or receive the trust property or to retain the same longer than necessary or for not taking any steps, for branch of trust committed by a co-trustee or co-trustees.

No Trustees shall be liable for any breach of trust committed by the co-Trustees except in respect of his own act and in respect of any property in his custody.

XI. POWER OF REIMBURSE:

The Trustees of this trust are entitled for reimbursement and also to the payment and discharge out of the trust fund, all expenses incurred by them or on their behalf in or about the execution of the trust and its objects and the powers of these present.


XII. ALLOWANCES TO TRUSTEE OFFICE BEARERS:

XIV. POWER TO MAKE OVER TRUST FUNDS:

If at any time all the trustees of the trust do not desire in remain trustees or to manage the affairs of the trust, they shall be entitled to appoint any bank, undertaking for the execution of trust business either along with or in conjunction with any of the trustees or any other person whom the trustees may think fit and proper or as the sole trustees for carrying out the affairs of the trust and managing and dealing with the trust estate or property in terms of this deed and on such terms as to remuneration or otherwise as they may think fit or in the alternative the trustees shall be at liberty to make over the Trust fund or any part thereof to any institution or trust formed for all any one or more of the objects for which this trust property in terms of this deed and to carry out the object of the trust after making over the Trust estate and / or the foundation properties to such trustees/s be completely absolved from any responsibility hereunder.


XV. REGULATION AND BYE-LAWS:

Act by passing resolution by majority of vote.

JURISDICTION OF COURTS: XVI.

The competent courts at Katwa or Burdwan Court within the ordinary original jurisdiction of the High Court at Calcutta shall have exclusive jurisdiction to decide any question regarding the interpretation and construction of this deed and / or administration of the trust and the related matters. In the event of such courts having concurrent jurisdiction with any other court or courts in respect of any claim or dispute against or by the trust or trustees or any other matter connected therewith, the competent courts all Katwa / Burdwan shall have the jurisdiction to entertain, try and determine such claim or dispute to the exclusion of such other court of courts.

The trust is an irrevocable Trust.

That no part of the trust shall be applied outside India.
